Improves Slightly

At present, STRS and the plaintiffs are favoring reinstatement of a COLA in any amount and at odds over whether the case is appropriately before any time soon seem to be very unattractive. the federal court or if it should be heard in a state court. Information available to us at this time suggests that STRS prefers that the matter not be addressed in federal court, the thinking being that the system is governed by state law and that state courts may be more sympathetic to the decision to suspend COLA payments.

On a related note, Ohio's largest public employee pension system, PERS, voted last September to freeze cost of living adjustments in 2022 and 2023. Unlike STRS, PERS must have legislative approval to implement its plan. Many legislators are hesitant to approve the freeze, in large part because of the onerous changes being made to the health care plan offered by PERS. One of those changes includes giving stipends to retirees who would then be responsible for buying their own coverage, for example, through the insurance marketplace.

STRS's 2019 Valuation Report shows slight improvement in the System's funded ratio (the percentage of funds available to pay benefits compared to actuarial liabilities) and in the funding period (the number of years needed until actuarial assets cover actuarial liabilities).

The funded ratio increased to 76.1% from the previous year's 75.5%. The funding period improved to 16.6 years from 17.8 years. (Ohio law prohibits funding periods in excess of 30 years.) Of these two

statistics, the more important one relating to a possible reinstatement of a COLA is the funded ratio. In the spring of 2019, STRS adopted a funding policy which included the goal of reaching a funded ratio of 100%. However, a provision included in the policy allows for a possible consideration of plan changes (restoring a COLA) when the funded ratio reaches greater. Given the small increase in the

Reduced Benefits Often Include COLA Cuts

There is at least one public pension system in each of the fifty states. Between 2009 and the end of 2018, plan benefits were reduced in all but nine states. The reductions took the form of increased employee contributions (4% phased in over four years under Ohio's 2013 reform plan), increases in the period used to figure final average salary (from 3 highest to 5 highest years in Ohio), decreases in the percent earned per year of service (2.2% in Ohio), increases in the age or service years needed to qualify for full benefits (a phased in plan through 2026 in Ohio), and COLA reductions.

According to the National Association of State Retirement Administrators, COLA reductions were made in 31 states. Changes in 17 states affected retirees, current employees and new hires were affected in 7 states, and new hires only were affected in 7 states.

In Washington, WEP and GPO Bills Stall

Two bills introduced early in the first session of

the 116th United States Congress, one in the House and one in the Senate, and both of which would repeal the Windfall Elimination Provision (WEP) and Government Pension Offset, have stalled with no action taken thus far on either. (For a detailed report on each bill, WEP and GPO, see the last newsletter on SCRTA's website.)

The House Resolution (HR 141) was introduced by Illinois Rep. Rodney Davis and is before the Social Security Sub-committee of the House Ways and Means Committee. Ohio's Sherrod Brown introduced the Senate Bill (S.521) which remains before the Senate Finance Committee.

We will keep you informed of any movement on either bill between now and the end of the current session (January 3, 2021).

EdChoice Spells Trouble for STRS

It has finally dawned on the Ohio legislature that Bill Siegferth, SCRTA Legislative Chair providing tuition vouchers for private and parochial schools has become a runaway freight train threatening the financial well-being of many public school systems in the state, including those whose fiscal integrity over the years has been strong. The awakening has resulted in the legislature pushing back this year's application deadline, giving lawmakers time to figure out a way to appease voucher-eligible families while at the same time not destroying local school district budgets. The House and Senate each have their own ideas on how to move forward. As of the date of this article, the House proposes to set income guidelines to determine voucher amounts, eliminating eligibility based upon poor school performance on the Department of Education's school report card. The Senate's idea is to reduce the number of vouchereligible schools from 1,227 to 425. The two bodies are now attempting to reach a compromise agreement on how to move forward.

Not too many people have given any thought as to how EdChoice vouchers are harmful to public school employee pension plans, including STRS. The

movement of kids from public to parochial and private schools means fewer public school teachers, lower public school payroll growth and, it follows, lower payroll contributions to the retirement system from both individual members and employers. Teachers in parochial and private schools are not members of STRS. It's not surprising that the shrinkage in payroll contributions was among the reasons listed by STRS Executive Director Michael Nehf in his 2017 letter to members explaining the need to suspend cost of living adjustments:

> "The results of these studies indicate that several factors, including lower than expected investment returns, longer lifespans among active and retired members, and lower than expected payroll growth continue to have a negative effect on the pension fund."(Emphasis added.)
