



#### **Bill Requiring Cost of Living Increases Introduced in Ohio Senate**

Sen. Teresa Fedor (D – Toledo, Lucas County) introduced S.B. 280 on January 12, 2022. If passed, the bill will amend Section 3307.67 of the Ohio Revised Code which is the current law covering cost of living increases for retired STRS members. As now written, the law states that STRS shall pay a 2% annual increase. The same law, however, allows STRS to increase or decrease the 2% payment. It was under this provision that STRS reduced the COLA to 0% in 2017.

Under Fedor's bill, STRS would be required to pay the annual 2% COLA beginning July 1, 2022. The big difference between the current law and the proposed changes in S.B. 280 is that the annual 2% payment could be adjusted upward, but in no case could it be reduced to less than 2%. There is no provision in the proposed amendment to allow a reduction regardless of how dire the System's financial condition may become. The bill has been referred to the Senate Insurance Committee.

It is reasonable to be concerned about the consequences a mandated COLA payment may have on other benefits paid for by the System, or contribution percentages paid to the System by active members and employers. For that reason, we have submitted several questions to Sen. Fedor about her bill and are eagerly awaiting her response.

the Ohio Federation of Teachers—were lukewarm at best when asked by Robin Rayfield at a recent ORTA town hall meeting if they support the bill. OFT's Darold Johnson said his organization has supported the introduction of S.B. 280 because "we need to have that conversation" (about a COLA). "While we support the conversation and we want to push the fund to figure out how to implement this, we think there are lots of different ways to get the revenues to do it. Board members need to talk to staff and figure out how to do it." When pressed by the host for a "yes" or "no," Johnson was interrupted as he began to answer the question. He nevertheless went on to stress that his organization represents active teachers as well as retired, and that active teachers want retirement plan improvements as well.

OEA's Robert Davis estimated the cost of a permanent COLA at \$13 billion. He noted that, "As we all know, if it wasn't expensive, if it was easy, STRS would be paying a COLA. We're for a COLA, but we think there has to be a way to pay for it." Davis emphasized increasing employer contributions to the pension fund, stating that there was "no other place to get the money other than from employers." He, too, was pressed by the host for a "yes" or "no" on OEA support for S.B. 280. His reply: "As currently written, we are not in support of 280 because there isn't funding to go with it to support the benefit."

#### My Opinion STRS Ohio Watchdogs?? How about

## STRS Ohio Mad Dogs.

At the risk of drawing more attention to them than I'd prefer, I am driven to share my opinion of a group calling themselves the STRS Ohio Watchdogs. They have created a three-pronged presence on social media...Twitter, Facebook and a website. They list nine members of the "pack," all of whom are retired with the exception of Julie Sellers who is president of the Cincinnati Federation of Teachers. The pack includes retirees who belonged as teachers/ administrators to the Ohio Education Association or the Ohio Federation of Teachers. Three of its most notable members are the plaintiffs in the COLA lawsuit (Bob Buerkle and Dean Dennis, both retired Cincinnati teachers) and Robin Rayfield, Executive Director of ORTA.

It strikes me that the COLA has become such a personal issue for the "pack" that it is virtually their sole focus despite the broader mission posted on their website. STRS management and Board members are relentlessly criticized. So is the Ohio Retirement Study Council (ORSC) which oversees all of the state's public pension systems. The Watchdogs

feed off a report for which ORTA paid \$75,000. The report's author, Ted Siedle, has frequently attacked The plaintiffs then filed suit in Franklin County STRS and ORSC as well. Siedle offered no evidence to support this As of this date and according to court records, the claim; I'm comfortable betting that he has no more evidence supporting it than I have proving that the moon is made of green cheese. Watchdogs have made similar statements and have attributed certain "demands" to thousands of teachers and retirees without supporting evidence. To my knowledge, the only evidence that exists about members' attitudes toward STRS is reflected in the independent surveys STRS has commissioned over time, the results of which show high confidence in the system.

> Watchdogs are constantly reminding their audience that STRS is the only pension system not paying a COLA. They don't tell you, however, what benefit cuts have been made by other Ohio pension plans in terms of COLA reductions and eligibility changes, or reductions in health care coverage provided by some of the other plans. And, in blatant disregard for the transparency and accuracy they so loudly demand from STRS, their webmaster continues to post the amounts of COLAs being paid by other systems for 2022, listing STRS alongside of them as an unqualified 0%. No such claim can be made responsibly insofar as STRS has yet to determine whether there will be a COLA in 2022. That determination will be made soon (as STRS promised it would do in 2017), and the prospects for a reinstatement of part or all of the COLA and other potential benefit improvements are encouraging, in

In my opinion.

Watchdogs have regurgitated ad nauseam Siedle's branding of the ORSC as a "failure" in providing the legislative oversight of the state's systems primarily because of a 2016 audit the Committee was supposed to conduct, but did not. The Watchdogs don't trouble themselves to explain to their followers why the audit didn't take place, although each of them surely knows why. As a result of the pension reform legislation passed in 2013, STRS began phasing in benefit changes over time (retirement eligibility changes, COLA changes, retirement contribution changes, etc.). Many of the changes occurred before and after the audit was scheduled to take place, and because STRS's financial condition was changing as each change became effective, it was decided that the audit should be delayed. (It is interesting to note that all of the changes STRS made in the name of pension reform, including the law applicable to the COLA adjustment, were supported by OEA, OFT and ORTA and approved by the Ohio House and Senate.)

Allow me to share just one more example. After the COLA lawsuit was dismissed by the U.S. District Court in August of 2021, the plaintiffs wrote, "Our COLA lawsuit against STRS Ohio is now filed in Franklin, (sic) County Ohio. Two months ago, Federal Judge Miller ruled that the case was best argued in Ohio," Now, we're all human and we all make mistakes, but Judge Miller didn't rule on anything. In fact, there is no Judge Miller in the U.S. District Court for the Southern District of Ohio. It was Judge Timothy S. Black who ruled, and he really didn't just rule that the case should be argued in Ohio. He dismissed the plaintiff's claims in their entirety and stated that with respect to one of the claims, his dismissal did not prevent the plaintiffs from pursuing the claim in the proper forum as legislated under ORC 3307.131, i.e., in Franklin County. I might be wrong, but it seems to me Judge Black may have been telling the plaintiffs they filed their case in the wrong court, at least as it applied to certain claims.

Finally, it appears to me that the Watchdogs group has become a forum for attacks against OEA by OFT affiliates in the group, and maybe OFT itself. ORTA appears to be siding with OFT. The evidence is not so subtle. During ORTA's February 2<sup>nd</sup> Town Hall, Dean Dennis, the COLA plaintiff, OFT retiree and ORTA Legislative Committee member, called for the ouster of the current STRS Bill Siegferth, SCRTA Legislation Chairman

administration and certain Board members, stating that he was "very upset with OEA's dominance on the Board and putting us in this position." All of that in the presence of an OEA legislative official who was invited and agreed to participate in the panel discussion! There have been other barbs directed at OEA-endorsed Board members over time, but nothing underscores the rift more than last year's STRS election. OFT-endorsed three candidates who were frequently mentioned on the Watchdogs web page while OEA- endorsed candidates were ignored. Of the three, only Rudy Fichtenbaum won election to the Board as a retired member. In my view, he was the Watchdogs' hero, the guy with an investment "plan" to restore the COLA, increase benefits, reduce contributions and blah, blah, blah. As it turns out, Fichtenbaum's plan was slammed by the STRS Board when it was submitted to them last November. And no wonder. It called for investing twothirds of STRS's funds (\$65 billion) with a company that has, according to the chairman of the STRS Board, no investing track record, no staff, no clients and no money under management. A complaint or two appeared on the Watchdog page claiming the plan, when presented to the Board, was not given a fair hearing. Never mind that the Watchdogs didn't tell us about the total lack of experience of the company in question, or about the fact that STRS had passed previously on the plan as too risky, or that the company tried to get buy in from Ohio's pension funds more than two years ago, and that OPERS, the largest of Ohio's funds, passed on the proposal back then.

Again this year, the Watchdogs page is pushing petitions for three STRS Board candidates, two active and one retired. The retired candidate is one of last year's unsuccessful candidates, Elizabeth Jones from Cincinnati (where else?). The active candidates are Julie Sellers, Cincinnati Federation of Teachers president and Steve Foreman, Assistant Superintendent in the Zanesville school district. OFT has endorsed Sellers and Jones. As was the case last year, there has been no mention of any OEA endorsed candidates on the Watchdog website.

The point of this opinion column is to demonstrate that like other social media outlets, there is no assurance that posted information is fact versus opinion, or truth versus deception on the Watchdogs page. We urge all SCRTA members to keep this in mind, regardless of the source of the information they may find on the internet.

- Served 151 boys and 133 girls residentially and non-residentially
