#### IN MEMORIAM



**RUBY WINTER** 

I joined SCRTA at the invitation of a friend. After attending a few meetings, I began part-time curriculum work and volunteered in Canton City where I eventually spent up to four days a week in various elementary schools. It didn't leave much time for SCRTA luncheon meetings.

In 2016 I started back to SCRTA and was greeted by a beautiful woman named Ruby Winters. I am told Ruby had been the luncheon coordinator for decades. She always made me feel happy to have shown up for SCRTA. She would smile and remind me that her daughter and I shared our name.

Ruby died June 19 at the age of 82. I was surprised to learn her age. She was a beautiful woman and had such a cheerful disposition that in my mind she was much younger.

Ruby taught third grade at Memorial Elementary in Barberton for thirty-four years. She was adored as shown by comments made on the funeral home's guestbook page by friends, families, co-workers, and even former students.

I wasn't surprised to learn about her many parties, seemingly tireless hostess duties, being there for her family and volunteering throughout the area. Her family listed many organizations, though not all, that benefited from Ruby's giving of her time and talents. She and her husband could have retired to Florida full time, but he knew she would not want to give up her important work here. She did so much it

Many of you came to know her through AARP, Children's Hospital, the Civic Theatre, and other area organizations. When I read in her notice the statement, "...she taught us love, grace, kindness, and patience...," the Fruit of the Spirit came to mind. In Galatians 5:22-23 (NRSV), the fruit contains "... love, joy, peace, patience, kindness, generosity, faithfulness, gentleness, and self-control." It was easy to see these qualities in our friend.



You may have heard "The Dash" poem by Linda Ellis. It was somewhat popularized by Senator Bob Dole and read at his funeral. It is a lovely story that gives meaning to how we spend our days between our dates of birth and death. The dash refers to the punctuation between the two years on one's death notice or gravestone.

The poet asks us to think not about how long the person lived but how the life was spent. She emphasizes what gives us true happiness such as spending time with loved ones and fulfilling dreams, making an effort to put a smile on someone's face and helping people in need. She asks us to think about living our "dash" to create memories for our loved ones to cherish. Ruby certainly left a multitude of stories in her dash! She is already greatly missed.

## STRS "Broken Beyond Repair?" You Decide

"Our pension system is broken, and it's broken beyond repair...Active teachers have the worst deal in America; they pay in more than their pensions are worth... Retirees are getting far less than what they promised...Everyone involved getting shafted except the people who experience working with corporate and public pension work at STRS; those people have the best plans. deal in America."

The comments above were part of Robin Rayfield's YouTube presentation announcing ORTA's STRS Board endorsements in this past spring's election. All of ORTA's endorsed candidates—Julie Sellers, Steve Foreman and Liz Jones (ret)—defeated incumbent Board members. These same candidates were also endorsed by STRS Ohio Watchdogs and Fix My Pension. Both the Watchdogs and Fix My Pension are home to the unsubstantiated accusations regurgitated by Rayfield in his YouTube remarks. Fix My Pension in particular has played fast and loose with the truth (they've lied); problem is, the people and/or the organizations responsible for the site remain anonymous.

Nevertheless, now that all three candidates have won and will soon take their seats on the STRS Board, we will be watching to see what dynamic leadership and actions they bring to the table to fix the "broken beyond repair" retirement system to which we belong.

In the meantime, the Ohio Retirement Study

Council (ORSC) doesn't appear to be in lockstep with the appraisal of STRS by Rayfield et. al. The ORSC is the official state agency charged with overseeing and policing the operation of all of Ohio's pension systems. They are responsible for advising and informing the state legislature on all matters relating to benefits, funding, investment and administration of all five systems. They have their own independent actuary and investment consultants who conduct each of the retirement systems reviews of independent of the systems' own actuaries.

On May 12, 2022, the ORSC hosted Jim Vovtko of RVK, one of the nation's largest, fully independent, employee-owned investment consulting firms based in Portland, Oregon, Vovtko has over 40 years' In addition to presenting investment performance reviews to ORSC members, Voytko and others responded to questions about claims made about STRS like those in Mr. Ravfield's endorsement video and elsewhere on social media.

ORSC Chairman **Phil Plummer** (R-Dayton) asked Mr. Vovtko for his expert opinion about the claims that STRS was a "poor performer" and "the worst (pension) system in the country." Mr. Voytko said he was "astonished" to hear such a charge and that he would like to hear the analysis leading to that conclusion, and that nothing in his report suggested that that was the case. When Plummer referred to the claim that STRS was "the worst performing pension system in the country," Voytko stated that the claim was "clearly not supported in the data." When asked by Plummer where the claims were coming from, ORSC staff member Jeff Bernard said that he had received numerous calls and emails on the claims and that staff concluded based on verifiable data that STRS was not a "poor performer." Bernard further stated that he asked several individuals making the claims to provide information or verifiable data supporting the claims, but he was never provided with a response.
