### **Ohio Auditor:**

#### ***No fraud, illegal acts, or data manipulation***

In 2021, ORTA collected \$75,000 in donations from its members and supportive organizations to fund an “audit” of STRS by the self-proclaimed “pension detective” and “Sam Spade of Money Management” **Ted Siedle**. To our knowledge, the **Ohio Federation of Teachers (OFT)** was the leading contributor. In forking over its 10 grand, OFT said, ***“Though we trust that STRS is generally managing their finances well, we feel it’s important to verify that through this third-party audit.”*** That explanation for its generous contribution strikes us as reasonable and honorable. Unfortunately, Siedle **did not** verify OFT’s trust that STRS was doing well; instead, he published a report highly critical of STRS management, the STRS Board and STRS investment advisors.

Thankfully, an audit conducted by the Ohio Auditor of State (AOS), the results of which were released at the end of December, provided the verification OFT sought that STRS is managing its finances well.

According to the AOS, its investigation was the direct result of the allegations in Siedle’s report and a subsequent flood of phone call complaints and concerns from retired teachers (orchestrated, we believe, by ORTA, the STRS Ohio Watchdogs and the STRS Members Only FB Forum). Among the most outraged complainers are ORTA President-Elect **Dean Dennis** and ORTA Executive Director **Robin Rayfield** who baselessly claimed, among other things, that STRS was “broken beyond repair,” that active teachers “have the worst deal in America,” and that Ohio retirees “are getting far less than what they were promised.”

After investigating all of the groundless complaints it received, the AOS reported: *“In summary, we found*

*no evidence of fraud, illegal acts, or data manipulation related to the \$90 billion held in trust by STRS for its members. STRS’ organizational structure, control environment and operations are suitably designed and well-monitored, both internally and by independent experts. These experts help assure that STRS follows applicable asset and liability measurement, reporting, investing and cash management laws, professional standards, and best practices. Our conclusions are consistent with the findings of these independent firms.*

Incredibly, after AOS’s findings were released, Siedle, a frequent guest on the Watchdogs’ blog, wrote a couple paragraphs headlined, “Huge Victory for Ohio Teachers,” and “It’s the shot heard around the world.” We have to wonder what “world” he’s living on where this shot was heard.

For the last several years, Siedle, his company (Benchmark Financial Services), and the now obviously closely aligned ORTA, Watchdogs and Facebook group have used, as evidenced by the AOS report, intellectual dishonesty, incomplete disclosure of facts and flat out untruths to discredit STRS and push the election of their endorsed STRS Board candidates.

The following is a condensed summary of a small sampling of allegations and the AOS finding for each.

**Allegation:** STRS is Paying Fees to PE Managers for Doing Nothing. (Note: PE = Private Equity, a form of investment.) **Conclusion:** Benchmark Financial Services (BFS) is simply incorrect in stating that these fees are for doing nothing.

**Allegation:** BFS claims there is a dangerously high risk of looting (illegitimate withdrawals) of pension accounts by STRS’ Investment Managers due to the absence of any diligent monitoring by STRS.

**Conclusion:** Under STRS control procedures, duties

are sufficiently segregated to mitigate the risk of “looting.”

**Allegation:** Investment Costs. The BFS report states “AI (alternative investment) managers, including hedge, venture, and PE, may charge asset-based performance and other fees amounting to approximately 8 percent -- 800 times greater fees than indexing.”

**Conclusion:** STRS has a lower overall cost of investments than peer pensions, as reported by CEM. This is due to a combination of STRS managing a larger portion of its portfolio internally at a lower cost, as well as paying less than peers overall for fees on external management. The fees STRS paid in 2020 on its AI compares favorably to peer pension averages.

**Allegation:** In a meeting with the AOS, ORTA alleged that a. STRS used unapproved, lower PE five-year benchmarks for fiscal years ended June 30, 2012 through 2020. These understatements improperly allowed investment staff to earn their PE bonuses. b. STRS never properly approved using actual results as the one-year PE or alternatives investment benchmark. c. STRS backdated the SIOP so it would appear to support these improper benchmarks. **Conclusion:** There is no support for these allegations. It is impossible for STRS to “backdate” reports posted annually on the AOS secure website.

**Allegation:** In September 2022, an ORTA press release stated (in relevant part) “[A] new look at STRS records and market performance show that STRS did not report any material loss in the value of its billions of dollars of PE holdings from January 2022 through June 2022... This glaring omission likely dramatically understated STRS’ losses because public equity stocks lost a quarter of their value during that same time period.” **Conclusion:** There is no support for these allegations.

**Allegation:** The BFS report states “Most objectionable was the loss of a promised Cost of Living Adjustment (COLA) in 2013 with no resumption in sight. **Conclusion:** Rev. Code § 3307.67(A) reduced STRS’ COLA from 3% to 2% beginning after August 1, 2013. The STRS Board has statutory authority to determine when and if to pay COLAs. (This authority was used in 2017 to reduce the COLA to 0% and again in 2022 to grant a 3% COLA.)

In spite of the AOS’s findings recognizing STRS as ranking highly among its peers in investment performance and operational efficiency, ORTA continues to pedal misinformation about the system. Repeated misrepresentations such as a teacher’s inviolable right

to a promised lifetime COLA (most recently appearing in a Watchdogs January 30 post) and the lie that teachers only receive 80% of what they contributed in benefits (refuted again by STRS on February 1) are an embarrassment to the organization and a disservice to its members.

### ***What’s in a Name?***

With all due respect and apologies to William Shakespeare, we don’t quite agree with Juliet’s opinion that names merely distinguish things or people, but alone have no real worth or meaning (“That which we call a rose/ By any other name would smell as sweet.”).

That which we’ve called the Ohio ***Retired*** Teachers Association we now call the Ohio ***Retirement for Teachers Association***. Is this name change, which became effective according to Secretary of State documents on December 29, 2022, meaningless, as Juliet would have us believe? I think not. We’ve written before about the very low percentage (12% when last checked) of eligible retirees who join ORTA (the old one). Just how much of a financial hardship this is causing the organization is not clear. What is clear, however, is that the name change is made to accommodate recruiting ***active*** teachers and, it follows, bring in more money.

It puzzles me why ORTA (whichever one) leadership—Kara Mendenhall (Past President), Dean Dennis (President-elect and Alpha Male of the STRS Ohio Mad Dogs...uh, Watchdogs) and President Chris DeMarco—would join with Executive Director Robin Rayfield to approve the change. Most active teachers belong to one of two state/national organizations and pay hundreds of dollars in annual dues. The state organizations are active in STRS matters, from endorsing Board candidates to attending Board meetings. And, as we’ve previously reported, both OEA and OFT were heavily involved (as was the old ORTA) in recommending and supporting pension reforms ten or so years ago. I question what would motivate an active teacher to pay additional dues to belong to the new ORTA. The organization explains

the change as "an effort to be more inclusive of active teachers" and is hoping that it will "help with membership and bring younger people into our organization." ORTA has set the annual dues for active teachers at just \$10. Retirees, whose lives have been devastated and vacation plans scrapped because of lousy retirement benefits and STRS's past decisions to reduce, then eliminate the COLA, will, ironically, continue to pay \$30 annually.

On a related note, we've heard that AARP is considering lowering the age eligibility for membership to 25. We'll look into that rumor and report in the next newsletter.

### BENEFITS OF GRATITUDE

There is an enormous amount of research on gratitude's effects. Gratitude journals are published to encourage individuals to get into the practice of daily writing. There are also free apps to remind us to make a few notes each day.

Research shows that levels of happiness can change. Practicing gratitude is one way to increase happiness. It enables us to find pleasure in even the small things such as a good cup of coffee. It shifts our perspective. The small and often routine things we see and think about can change our mindset.

Laurie Santos teaches at Yale. Her course entitled "Psychology and the Good Life" holds the record for the most popular class in the university's history and has since been made free to high school students online. Santos says even though it takes little time and is free, the benefits are quite powerful.

This is just a snippet of the benefits of counting our blessings even once or twice a week: better sleep, lower stress, healthier eating, lower risk of heart disease, lower symptoms of depression, and improved personal relationships. Some authors report just thinking about your thankfulness is also okay. They do not use the word "prayer" in the reports, but I believe they may be hinting that thanking God for our blessings is healthy for us.

NPR reported on high school students who kept gratitude journals. The use "...decreased materialism and bolstered generosity among adolescents."

Several studies show great benefits of sharing one's gratitude by writing letters of thanks to others. Reading the thank you letters aloud greatly increases the positive effect on the writer. Something to think about!




