# COLA LAWSUIT TABLED FOR AT LEAST A YEAR

We began reporting on the COLA lawsuit when it was filed by two retired Cincinnati teachers way back in 2019. One of the teachers is STRS Ohio Watchdogs alpha male Dean Dennis. In the judgment may hold for their retirement benefits. meantime, Dean Dennis was elected the bv eight-member ORTA Board to serve first as president elect, then as ORTA president beginning in August.

The case hasn't progressed much over the nearly two years since it was filed in Franklin County. At present, the trial date is set for July 29, 2024, more than a year away. Motions to extend the trial date have been filed jointly, i.e., both parties (STRS and the Plaintiffs) agreed to petition the Court to extend dates. Three important dates scheduled for the coming months are the disposition of the Plaintiffs' Motion for Class Certification scheduled on September 29. While we've referred to the lawsuit as a class action suit in the past, a class has apparently not yet been certified in Franklin County. A second important date is February 9, 2024. That's when the Court plans to hear The Plaintiffs' Initial Settlement Demand. We're guessing this is when the plaintiffs will float suggestions about what STRS needs to do to settle the case short of proceeding to a full-blown jury trial. The third date is March 8, 2024. At that time, STRS is

expected to respond to the plaintiffs' settlement proposals.

The relief sought by the plaintiffs includes a resumption of the annual 2% cost of living payment, an award for damages and/or restitution representing the amount of retirement benefits lost since the COLA was suspended, interest on lost benefits and payment of attorneys' fees and case-related expenses.

# Steen Removed from STRS Board by Governor, Files Legal Challenge

Gov. Mike DeWine has removed and replaced his appointee to the STRS Board. Under Ohio law (ORC 3307.05 C.) the governor of Ohio appoints one member to the eleven member STRS Board for a four -year term. Wade Steen was first appointed to the Board by John Kasich in 2016 and then reappointed by DeWine in 2020. DeWine offered as reasons for replacing Steen in the midst of his second term his meeting attendance record and concern over the impression that Steen was acting as an advocate for a specific investment firm. Steen has filed a legal challenge to the Governor's decision in the Tenth District Court of Appeals, claiming the law does not permit his removal in the middle of a term and that DeWine's characterization of his attendance record is inaccurate.

Steen is among ORTA's "favorites" on the STRS Board, so much so that the organization has opened a See Legislation, Page 4



defense fund to help pay his legal fees. The decision to start the fund was made by a small circle of policy makers known as the ORTA Executive Committee which includes the president, the past president and the president elect. ORTA is soliciting contributions from its members to bankroll the fund.

Steen is perceived by many as advocating along with Board member Rudy Fichtenbaum for the controversial "investment firm" known as QED. According to reliable sources, the firm has no clients and no experience investing money for clients. Efforts last year by Steen and Fichtenbaum to consider a "trial" investment with QED were quashed by a majority on the retirement board. The pair ultimately wanted to hand over about two-thirds, or \$65 billion of STRS's investment dollars to the startup company.

ORTA has been criticized as a supporter of the same firm and its investment "strategy" by an editorial board member of an Ohio newspaper. The writer accused Fichtenbaum and ORTA and "the teachers who support them" as having "materially misrepresented this proposal from day one."



Summit Metro Parks, established in 1921, manages 15,000 acres, 16 parks and more than 150 miles of trails. They have eight open-air shelters and seven beautiful enclosed lodges available for rental. One catch is that you must reserve a shelter or lodge a year in advance. Still, it is worth a try to see if the shelter you desire is available on the date you prefer. To participate in the Ronald McDonald House SCRTA, Pull Tab Incentive Program, please turn in your pull tabs at general luncheon meetings. We would like to track SCRTA members' participation. Rozanne Emich will collect the tabs at the meetings and deliver them to the Akron Ronald McDonald House, at her convenience, on behalf of SCRTA members.

- **1.** Bring the pull tabs in a quart or gallon sized zip lock or zipper bag to a General Luncheon meeting. Print your name and phone number on the bag. Please do not bring the tabs in the little cardboard houses, glass jars, etc. (Note: We will provide a supply of quart and gallon sized plastic bags at the General Meetings for members who are participating in the program.)
- **2.** If you sign up on the tracking list and/or print your name and phone number on the <u>full</u> plastic quart storage bags, you will automatically be entered into a drawing for a free lunch or gas card at a future luncheon meeting.
- **3.** Also, each time you bring your tabs to a meeting in a <u>full</u> plastic storage bag, you are invited to take one item from the SCRTA Pull Tabs Goody Basket. One item per bag of pull tabs per general meeting at the April, June, September, or November meetings.
