## STRS Member Benefits Deputy Director to Speak at June 3<sup>rd</sup> Luncheon

In addition, the board passed temporary reductions in the number of years of service required for reduced and unreduced retirement benefits.

## Legislative and Legal Updates

### Ohio House Continues All-Out Attack on Public Schools

The Ohio House recently passed its version of the next two year state budget. It includes, not surprisingly, further blatant attacks against public education in the state.

One provision in the bill eliminates elected state board of education positions and reduces the number of board members to five, all appointed by the governor. The board currently includes nineteen elected and eight governor-appointed members. The latest attack follows the renaming two years ago of the Ohio Department of Education to the Ohio Department of Education and Workforce, a move that was accompanied by the stripping away of much of ODE's authority. In another example of the House's unwavering allegiance to charter and private schools, the proposed five-member board includes a member from each group, leaving traditional public school members with just 60% of the board's makeup.

Meanwhile, the Fair School Funding model, which has been in place for the last four years and was intended to address the years-ago Supreme Court ruling that Ohio's school funding formula was unconstitutional, was supposed to receive a \$666 million increase in this budget. The House bill reduces that amount by roughly two-thirds to \$226 million while increasing private school funding by more than double that to \$500 million.

As of this writing, the budget bill moves on to the Senate. The budget must be completed by the end of June.

***"Reformers took a majority of the Ohio State Teachers board. Now their overhaul efforts are fizzling in the face of reality."***

The headline above is not mine; it's from an April 8 online ***Pensions & Investments*** (P & I) article by **Rob Kozlowski**. In addition to posting news daily online, P & I publishes a bi-weekly magazine considered by many as the newspaper of record for institutional investors. P & I is rated by media watchdog ***Media Bias/Fact Check*** as least bias, highly credible, and mostly factual.

The crux of Kozlowski's article is that a series of elections since 2021 has given a majority of STRS board seats (6) to "a group of self-proclaimed reformers." (For the record, the majority of six includes one retiree seat and five active teacher seats, four of which were elected and one appointed.) Kozlowski attributes the election results to "social media-driven outrage by retirees led by advocacy organization (the) Ohio Retirement for Teachers Association..." His mention of social media is obviously in reference to ORTA partners STRS Ohio Watchdogs and the Ohio STRS Member Only Forum. ORTA and their online lemmings have pushed for investing primarily in index funds, which are passive investments and, as such, would save STRS tons of investment advisor fees, bonuses, etc., thereby allowing STRS to restore what they believe was a promise of a life-long 3% COLA.

Kozlowski noted that the "reformers," all of whom were endorsed by ORTA, "campaigns with platforms that included proposals to reduce costs by cutting investment staff bonuses, moving to passive investments and eliminating alternatives in order to restore cost-of-living adjustment benefits lost after a pension reform law was passed in 2012," suggesting their platforms were closely aligned with ORTA's position.

The "reformers," however, joined the remaining board members at their March 19 meeting in a unanimous vote for an asset allocation investment plan that differs drastically from their campaign positions and that of ORTA & Co. The allocation plan was

recommended by STRS investment consultant Meketa.

**Keith Brainard**, a research director for the **National Association of State Retirement Administrators**, offered one reason why “reformers” supported an asset allocation plan so different than what some suggested during their election campaigns. STRS board members are required to complete an orientation program early in their tenure and to attend continuing education programs at least twice a year. “The fact that the board has set an asset allocation that seems to be different than what was the basis of the popular election of some of the trustees suggests that perhaps some of this continuing education is hitting its mark,” Brainard said.

STRS Interim Executive Director **Aaron Hood** also commented on the value of the education initiatives during his April 9 meeting with the Ohio House Public Insurance and Pensions Committee. Noting that more than half of the STRS board has been in place for less than a year, Hood said he believes that “some of the new board members have gotten much clearer in understanding... cutting through some of the noise that is out there... instead of getting their news from Facebook pages, they’re starting to get it from the reality of all the things that are factual and data driven.” Members interested in hearing Mr. Hood’s comments to the committee may visit <https://www.ohiochannel.org/video/ohio-house-public-insurance-and-pensions-committee-4-9-2025>. The P & I article does not portray “reformers” in a very positive light given the contrast between their campaign pledges and endorsements and their most recent votes in favor of the new asset allocation plan. But that contrast is good news for members, as it shows a group willing to listen and cast votes based on advice from experts in the pension and investment field, and not on the basis of less than fully accurate social media and ORTA complaints

about benefit changes stemming from the universally accepted pension reforms initiated ten to fifteen years ago. **Bill Siegferth—Legislative Chair**

I, **Rachel Robinette**, am a senior at Green High School and will be going to college at Kent State University in the fall with a major in Early Childhood Education!

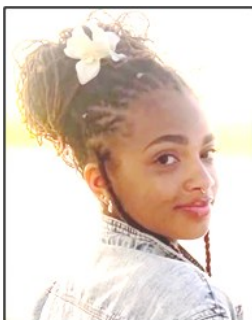

### **SCRTA TEACHER GRANTS IN ACTION**

As the 24-25 school year winds down, we are receiving exciting feedback from our grant recipients.

**Scott Aten** from Green Middle School sent pictures and video and reported: *"We used the grant money SCRTA provided to purchase the necessary supplies for our 26-student Robotics Team to build an Ant-Weight plastic combat bot (robot car) that was used to compete in the National Robotics Challenge in Marion, Ohio in April. The team's bot made it all the way to the championship match, where it lost, but received the silver medal. Our students are very excited about designing something different next year."*

**Ashley Longville**, from Lincoln Elementary in Cuyahoga Falls created a "hands-on cooking experience" station for her Special Education students. It includes a toaster oven, toaster-oven bakeware, griddle, blender, mixing bowls, hand mixer, cutting boards, oven mitts and cupcake liners. These items can be used over and over for several school years.

**Melissa Clapper** of Green Elementary School sent video and pictures of the small terrariums her first-grade classes created. She purchased 48 plastic Mason jars with lids, terrarium plants, artificial moss, mushroom decorations, gravel and terrarium soil. Her video shows a first grader explaining the water cycle, as he proudly shows us his terrarium, which is creating its own water-droplet rain!

**Laurie Thompson** from Ritzman Elementary School purchased books her 5<sup>th</sup> grade students are using to learn about various famous persons and will create a living Biography Museum to present to K-4 students in her building.

### Notes from the Archives on Scholarships

In August of 2003, SCRTA President Bob Frutchey appointed four Management Board members to serve on a scholarship committee. The committee was created after four years of discussions concerning scholarships. That October the Board accepted the recommendations from Mary Anasson, Blin Scatterday, Betty Dyak, and Gene Thrall. Scholarships were offered to education majors from Summit County who were children of members. The following August SCRTA awarded a scholarship to Adam Dockus. The next few years, it appears few scholarships were awarded in part because there were very few applicants. No records were filed about recipients for several years. Sometimes the minutes show a scholarship was given, but the recipient was not named. If you can add information about the years 2004 to 2013, please let me know.

The major ways of funding the awards have varied slightly over the years. In July 2005 the Board passed a motion to collect donations in cups on the luncheon tables, one-half going to school supplies for children living at the Battered Women's Shelter and one-half going to the scholarship fund. The Board passed a motion in 2014 to donate \$3.00 of each new member's dues to the fund. Vicky Shaw and Judi Hill volunteered to cochair the Scholarship Committee in 2014. Since then, 29 high school and university students have received SCRTA scholarships. We have usually given two each year, although for the second time, we are helping four students in 2025. Our co-chairs have implemented fund-raising raffles, sales, the Acme Cashback program, and have continued to encourage donations from members for this important student assistance. 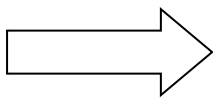

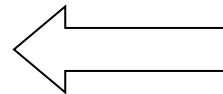

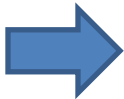
